- **4.Describe the proposed activity including information about course curriculum or agenda topics if applicable.:** The funding provided by NAR's Housing Opportunity Program will be used in conjunction with a grant received from the California Association of REALTORS Housing Affordability Fund. The Bakersfield AOR received \$50,000 from CAR for closing costs for first time homebuyers. We are working with our local Housing Authority of Kern County to distribute 25 awards of up to \$2,000 for first time homebuyers using a REALTOR member. 10 awards (or \$20,000) are dedicated funds for clients of the Housing Authority. The Housing Authority will provide financial classes to recipients of the awards. The NAR Housing Opportunity funds will be used to pay for the financial literacy classes for ALL recipients of the awards for closing costs, which will cover the 15 recipients who are not clients of the Housing Authority.
- **5. Why is the association interested in conducting the activity?:** We are excited about this opportunity to help first time homebuyers. Many first time homebuyers are often surprised by the amount of cash-on-hand required for the purchase of a home. There are a lot of existing programs that help with downpayment assistance, but very few resources to help with closing costs. We want to ensure all clients of our members are able to see their dream of becoming a homeowner a reality, and not fall out of escrow because of closing costs.
- 6. What are the outcomes that the association expects to accomplish through this activity?: We expect 15 recipients of the Housing

Affordability Fund to participate in the financial literacy classes, to be provided by the Housing Authority of Kern County.
