Please explain your ongoing RPAC fundraising activities, RPAC education and recent RPAC related events.: For 2021 we have held one event, our ARPAC Education Mixer, that accomplished not only awareness of RPAC and its importance, but it helped us gather over twenty pledges. We have two other events planned for raising money for ARPAC in 2021 and they are our BAR Pet Pageant and the ARPAC Auction & Casino Night. The BAR Pet Pageant is inspired by NAR's Pet Photo contest and to allow for our association's members to register their pet(s) for \$50.00 per submission to then be voted on with the minimum \$15.00 per vote and the pet with the most raised will win and be announced at our Auction. Our ARPAC Auction will have a Live auction, casino games (with door prizes), and the announcement of our BAR's Pet Pageant winner. This auction and Casino night will also include a speakeasy theme and we will provide a V.I.P section for our Major Investors where they will have an express lane for beverages.

Include promotional activities, time and location, target audience and fundraising activities.: We are planning our annual ARPAC Auction this August 20, 2021, from 6:00 PM to 9:00 PM CT. We will host our members at Regions Field, in Birmingham, AL, to share in food and beverages. Our fundraiser will include a Live Auction and casino games that members can play to win door prizes. We have included flyers, emails, and newsletters given out to our membership for this events promotion. Our Affiliates and Events Director has put out information to our affiliates for sponsorship of games, tables, and even auction items. We have posted this event into Aristotle to use Webforms before and during the event, and we have posted this event into our own system for our members to see on our website's calendar. The target audience of this activity is our entire membership we hope to create both new participants and major investors as part of the effort.

Our Auction items have been acquired through purchases, donations, and sponsorships. Our Sponsorships have been marked almost triple the activity or tables expense. We intend on registering our members for either the \$40.00 per person or for \$70.00 per couple where we supply them with casino chips up to \$1000.00 (or \$2000.00 for the couple) in play money that can be used to purchase tickets for the door prizes. These entry tickets go towards the event venue, food/drinks, and activities. If more tickets are required, we have stations prepared with an Aristotle webform for more investments to be made on the spot and the provision of more casino chips will be provided. Our members will have the casino games place chances to win prizes either through trying their luck at the games or by purchasing more and more chips for tickets. The Auction itself will include a multitude of items and they will be auctioned off at above acquired value to go above its value and to allow for members to elevate their Major Investor status. We have obtained 119% for our investment goal for 2021 and only 22 major investors paid or pledged currently. We have a vast net to cast to members that have given to RPAC but have not made the leap to becoming a Major Investor.

How will you improve this year?: Our CEO, the incoming VP of the Government Affairs Department at our association, and myself have not ever submitted a Partnership grant application from the Birmingham Association of REALTORS®. The past events from our association have been handled by us for applying, using, or the follow up for this grant. Our CEO, Amanda Creel, has done work in her past associations that can reflect to how improvements will be made and the best lesson I can take from this application is to keep steady records of the past grant submissions and the reviews of those events for future usage. This year to also help improve the success of our 2021 event we are requesting a substantially lower amount to be able to focus more on the return from this event. I have talked with Jamison Huff about our previous grant applications, and we have had approval for both 2019 and 2020 but did not follow up with a reimbursement request, therefore it is our main objective to (if we are approved for our grant request of 2021) follow up with our results to further this associations RPAC member investments.
