How will this program or activity enhance and improve the relationship between the REALTOR® Association and the local multicultural board or chapter?: : The event "Black History Month: Empowerment Through Heritage" agenda will be celebrating the history of homeownership for Black Americans. The agenda will include: -speaker: Allegra House, State President Women's Council of REALTORS® New Jersey on the intersection of race and gender within real estate history and the importance of DEI initiatives within the profession -speaker: National Association of Real Estate Brokers (NAREB REALTIST), New Jersey Association of Minority Real Estate Professionals (NJAMREP), Regional President, Mayarani Smith on democracy in housing and homeownership. This event will help us continue to build strong relationships to our local chapter of NAREB, as we look to further our mission for advocacy for all REALTOR members and homeowners within our association.

Describe the proposed activity including specific details about how the activity will be executed.: The event will highlight the advancements that Black American REALTORS within the industry have made, as well as Black American homeowners through adversity, including homeownership and fair housing. In addition, Greater Bergen REALTORS hopes to expand our DEI committee to raise awareness

and increase member participation. As our DEI Committee grows in number and stature, we remain committed to the Black History Month event becoming not only a staple of the Committee, but something that expands into a larger event for a great cause.

- 3. Why is the association interested in conducting this activity?: Greater Bergen REALTORS has over 8,000 members from many diverse backgrounds, and our REALTOR members serve a diverse public across Bergen County. In keeping with our mission to provide connections, advocacy, resources, and education, we know the importance of providing our members with educational events that help them learn more about different DEI initiatives, such as democracy in housing. The Black History Month event not only does this, but it sheds understanding into the journey for diverse groups of homeowners who need well educated and professional REALTORS on their side. Our speakers who attend from local organizations are able to bring this knowledge to our members, and we are very grateful for their participation. Each year we receive great feedback from our members who had many takeaways from the event.
- **4. How will the association measure the success of the activity?**: This will be our fourth annual Black History Month Celebration, in 2020 we held our first in person celebration with a great turn out of over 100 attendees. Following COVID, we hosted a virtual event. In 2023, we hosted the event in person again, increasing our community outreach and elucidating the importance of inclusivity in the real estate profession. Each year, we have representatives of the leadership team of NAREB join to speak and shine light on what their organization does to advance DEI initiatives within the profession. As our association grows, we have seen such positive feedback from this annual event, and we would like to see it become an event that includes many multicultural real estate organizations so we can have a larger positive impact in our area and the industry.
- 5. What are the outcomes that the association expects to accomplish through this activity?: We would like to connect further with NAREB so that we can lean on one another as associations who share common goals for our members and the public. Additionally, in its infancy, this event was an opportunity for our DEI Committee to gain traction, but in our 4th annual year, we want the DEI Committee to expand further. As an association that is highly involved in our community, and among other local and state boards, we want to continue to grow our committees so that we are providing our members and the public with the best level of DEI knowledge, tools, and education.
- **6.** How will the association assess the outcomes and long-term benefits of this grant?: As we run metrics for the event, we can see that each year we have a larger attendance at the event. With over 8,000 members it is important to provide an array of events that interest a wide array of REALTOR members. We have crafted strong connections to other multicultural organizations and county and state figures who help transform the event into something that has great takeaways for our members. Greater Bergen REALTORS was one of the co-hosts of the regional DEI Summit, that was started only 2 years ago. Alongside other associations, including New Jersey REALTORS and NAR, we want to see our efforts rewarded with larger attendance, exposure, and opportunities for members to learn about the importance of DEI in the real estate industry. Events like our Black History Month Celebration are a great opportunity for exposure, building relationships, and building our association committees.
