Describe the proposed initiative including key details about how it will be executed.: The West Central Association of REALTORS® is excited to announce its upcoming Homeownership Seminar tailored specifically for high school seniors. This dynamic and informative event will take place on March 12, 2025, at the Lima Civic Center in Lima, OH (Allen County). Serving the communities of Van Wert, Hardin, and Allen counties, the seminar aims to empower the next generation with the knowledge and tools needed to embark on their journey toward financial independence and future homeownership. Building on the success of last year's event, which saw participation from over 400 high school seniors, this year's seminar is anticipated to welcome 500-600 students, including schools eager to participate for the first time. The expanded program will cover essential topics such as: Understanding Credit Scores: How they work and why they matter. Budgeting Basics: Practical steps to manage personal finances. Opening a Bank Account: Tips for getting started with financial institutions. Navigating Credit Cards: Responsible use and potential pitfalls. In addition to valuable educational sessions, attendees will enjoy a complimentary lunch, exciting prizes, and engaging games, all generously sponsored by our affiliate members. This event represents an incredible opportunity to prepare high school seniors for financial success and responsible decision-making. With a larger venue, a broader reach, and an engaging lineup, the 2025 Homeownership Seminar promises to be our best yet!
- 4. Why is the association interested in conducting this initiative?: The West Central Association of REALTORS® is dedicated to

supporting the growth and success of the communities it serves. By conducting this Homeownership Seminar, the association seeks to empower graduating high school seniors with the essential financial knowledge and skills they need to navigate their transition into adulthood. This initiative aligns with the association's mission to promote responsible financial decision-making, cultivate future homeowners, and strengthen the local economy. Educating students on critical topics such as budgeting, credit, and banking equips them for personal success. It fosters a culture of financial literacy and community engagement, ensuring a brighter future for all residents in Van Wert, Hardin, and Allen counties.

How will this initiative advance the association's housing opportunity goals?: The West Central Association of REALTORS® aims to offer this Homeownership Seminar as an outreach and educational engagement initiative, targeting community members most likely to invest in their first home. By equipping high school seniors with essential knowledge about the home-buying process and the long-term value of homeownership, the association seeks to foster a more informed and prepared community. Additionally, this event serves as an opportunity to strengthen the relationship between REALTORS® and the communities they serve, building trust and encouraging collaboration for future endeavors.
- **6. How will the association measure the success of the initiative?:** The long-term success of the Homeownership Seminar will be measured by the West Central Association of REALTORS® through ongoing collaboration with school administrators to track the progress of participating graduate students. Short-term success will be evaluated based on the level of student engagement during the seminar's activities and the total number of attendees. Last year's event saw participation from over 400 students, alongside active involvement from community leaders, setting a strong foundation for continued growth and impact this year.
- 7. How will REALTORS® be involved in the planning and implementation of the initiative?: Understanding the home-buying process is a critical component of a successful real estate transaction. This seminar is designed to educate high school seniors on fundamental topics such as credit scores, opening and managing bank accounts, and navigating the real estate transaction from start to finish. By offering this educational opportunity, the West Central Association of REALTORS® advances its housing advocacy goals, empowering potential future buyers with the knowledge they need while emphasizing the vital role that REALTORS® play in guiding and supporting clients throughout the home-buying process.
- **8.** How will association staff be involved in the planning and implementation of the initiative?: REALTORS® from the West Central Association will take the lead in planning and executing the Homeownership Seminar, with valuable support from the association's Executive Officer and local community leaders. Serving as speakers for the event, REALTORS® will share their expertise and insights, working in collaboration with West Central affiliates and additional vendors to deliver a comprehensive and impactful program.

Describe their role(s) in the initiative.: West Central will be supplying funding toward marketing and an in-kind contribution of staff time. Attendees are expected to be between 500-600 students, not including REALTOR members and vendors. We are not charging for this event as we are trying to promote the attendance of potential home buyers. We have ten affiliates that will be providing door prizes valued at \$25 a piece, and who will also be present to participate. The local school administrators will be there to help chaperone the event with the high school seniors encouraging them to learn more. Community leaders will also be in attendance to help encourage our younger generation about the responsibilities of owning a home.
